Terms and Conditions for Abandoned Vehicle-Public Auction

- The Abandoned Vehicle Auction will begin at 9:00 AM. Gates will open at 8:00 AM.
- If you are trying to redeem your own vehicle and you are the winning bidder you will still owe the entire bill in order to get the vehicle back.
- All vehicles have a \$400 minimum bid.
- All buyers must register and obtain a "Buyer's Number" in order to bid.
- You may not use another person's number to bid.
- You are responsible for all bids with your Buyer's Number.
- All fees are due by Friday, the day after the sale @ 4PM.
- If you have not paid, you do not have a car, and you will not be allowed at any future auctions.
- All fees must be paid by cash, cashier's check, or pre-approved company check.
- **WE DO NOT ACCEPT CREDIT CARDS.**
- There shall be no mechanical work done on our lot.
- All sales are final, all vehicles are sold "AS IS".
- No items are to be removed from the vehicles until the fees have been paid and the vehicle has been removed from our lot.
- No one is to enter a vehicle once it has been sold; even if you are the purchaser; until the vehicle has been paid for.
- No wandering outside the viewing area to look at other vehicles in the storage yard.
- No one under the age of 16 will be permitted at the auction.
- "Tow Out" prices may be obtained at the office.
- All vehicles must be removed from the auction lot - no later than 5pm the next Thursday following the sale, if they are not removed there will be a \$20 per day storage charge for each vehicle.
- Sorry, but there are **NO PUBLIC RESTROOMS** or **TELEPHONES** available at our auctions.
- By bidding in our auction, you agree to all terms and conditions.

ABANDONED VEHICLE TITLES

- **WE WILL NO LONGER BE PROCESSING TITLE PAPERWORK FOR VEHICLES PURCHASED AT THE AUCTION.**
- We cannot guarantee that a title will be issued for an Abandoned Vehicle.
- Examples:
 - THE VEHICLE MAY HAVE BEEN PREVIOUSLY REPORTED AS "JUNKED" AND NO TITLE WILL BE ISSUED, OR IT MAY HAVE A SALVAGE OR REBUILT TITLE AND THIS IS SOMETHING WE ARE NOT AWARE OF UNTIL A NEW TITLE IS APPLIED FOR -**DO NOT DO ANY WORK TO A VEHICLE UNTIL YOU HAVE THE TITLE IN YOUR HAND***
- You must fill out the "Buyer's Information" sheet in order to be issued your Abandoned Vehicle Bill of Sale.
- Every buyer will be issued an Abandoned Vehicle Bill of Sale that may be taken to your local probate office to apply for a title.
- No bill of sales will be issued until you have paid for (all) your vehicle(s).
- No vehicle may be driven off the lot until your bill of sale has been issued.
